

## **COMMUNITY OUTREACH RELEASE**

This Community Outreach Release (the "Agreement") is made and entered into as of the date of execution, by and between Prestonwood Baptist Church, Inc. ("PBC"), a Texas non-profit corporation, and the community outreach volunteer ("Volunteer").

Volunteer agrees to serve as a helper/volunteer to complete various tasks to meet the needs of any outreach opportunities of any nature, whether or not organized or directed in any way by PBC, in which Volunteer chooses to participate as a perceived or actual representative of PBC during the 2019 calendar year (the "Services").

Volunteer is aware that the Services involve inherent risks, dangers, and hazards which can result in serious personal injury or death. Volunteer further acknowledges and agrees that there are certain obvious and necessary risks involved in the Services, including, but not limited to, performing on raised or uneven surfaces, lifting heavy items, and working near motorized vehicles and/or equipment. Volunteer freely and expressly agrees to assume and accept all known and unknown risks of injury, death, and property damage arising out of the Services.

At all times while on PBC property and at the service opportunity location, Volunteer agrees to abide by PBC guidelines, requirements, and use restrictions, and will conduct himself/herself in accordance with the policies and values of PBC.

Volunteer agrees that if he/she is under the age of eighteen, the parent or legal guardian of Volunteer will sign this form where indicated.

Volunteer knowingly and voluntarily releases, waives, discharges, covenants not to sue, and agrees to indemnify, defend, and hold harmless PBC, and all other related entities, their officers, employees, agents, members, and assigns, as well as any ministry partners involved in the 2019 outreach opportunities contemplated herein (the "Prestonwood Parties") from and against, any suits, claims, complaints, damages, judgments, penalties, fines, losses, costs, and/or expenses, including, but not limited to attorneys' fees, court costs, and legal expenses, of whatsoever kind and nature, imposed upon, incurred by, or asserted against the Prestonwood Parties in any way related to or arising from the execution, enforcement, or performance of this Agreement or of Volunteer's duties and Services described herein. Volunteer's duty to indemnify, defend, and hold harmless the Prestonwood Parties pursuant to this section includes, but is not limited to, claims related to or arising from bodily injury or death, or from damage to property, and the loss of use resulting from such damage, regardless of whether such injury, death, or damage was caused in whole or in part by any act or omission by the Prestonwood Parties. Volunteer agrees to further indemnify the Prestonwood Parties and hold the Prestonwood Parties harmless from any claims, demands, liabilities, actions, suits, or proceedings asserted or claimed by any third parties related to or arising from the performance of Volunteer's duties hereunder. The provisions of this section shall survive the expiration of this Agreement.

This Agreement shall be governed by the laws of the State of Texas, with jurisdiction in Collin County.
